

## **Terms and Conditions of On-Bill Donation Program: Donations via your Ignite Telecom bill**

### **BACKGROUND**

1. Thank you for agreeing to donate to Telco Together Foundation ACN 154 589 447, the Trustee for Telco Together Fund ABN 91 256 972 804 trading as Small Change Big Change (TTF). TTF is a charity registered with the Australian Charities & Not-for-profits Commission
2. Ignite Telecom Pty Ltd ABN 70 169 082 795 (Ignite) is assisting TTF by running the on-bill donation program (Program), through which Ignite customers may make donations to TTF by way of add-on to their Ignite monthly account.

### **THE DONATION**

3. You have agreed to donate a nominated amount each month (\$1, \$2, or \$5 AUD) to TTF (TTF Donation). The TTF Donation will be added to your Ignite Account, and will be billed to you together with your regular payment on your Ignite services.
4. 100% of your nominated TTF Donation will be provided to TTF.
5. Your TTF Donation is added to your Ignite account, will appear on the each month's bill and will repeat monthly until cancelled by you or until your services are no longer with Ignite (whichever occurs first). Once made, your TTF Donation cannot be refunded.
6. All payments made on your Ignite account are applied first to the payment of services supplied to you by Ignite before payment of TTF Donation occurs. If you fail to fully pay TTF Donation for two (2) or more consecutive months, Ignite may, in its discretion, remove the recurring TTF Donation.
7. Ignite accepts no liability for the manner in which TTF applies your TTF Donation/s in any particular way or to any particular purpose. If you are unhappy with TTF's use of a TTF Donation, you should contact TTF directly.

### **CHANGING TTF DONATIONS**

8. You may cancel future TTF Donations, increase or decrease your TTF Donation by providing Ignite 30 days' written notice.

### **TAXATION OF TTF DONATIONS**

9. TTF Donations are GST exempt and individual TTF Donations over \$2.00 are tax deductible. A gift of money less than \$2 is not tax deductible. However, you can add together a series of gifts to a Deductible Gift Recipient in an income year to work out whether your gift is \$2 or more. You will need to save your Ignite bills as evidence of your TTF Donation for taxation purposes if you wish to claim them as a tax deduction. Please consult your tax or financial advisor for specific questions about your TTF Donation and/or tax deductions.

### **PRIVACY**

10. When making a TTF Donation, a variety of personal information may be collected and shared with TTF, who may send you additional messages which you may opt out of at any time. For further information about how Ignite collects and uses your personal information, please see Ignite Privacy Statement.
11. Ignite may modify or cease the Program at any time for any reason without notice or liability to you or any other party.
